Lord (Peter) Goldsmith QC, PC, is London Co-Managing Partner and Chair of European and Asian Litigation at Debevoise & Plimpton LLP. He joined the firm in September 2007. He is based in the firm's London office.

Lord Goldsmith was appointed Attorney General in 2001, acting as chief legal adviser to the government on matters of domestic, European and international law. He represented the government in numerous cases in UK and international courts. He also argued as counsel in the House of Lords two of the 15 cases regarded as the most important British cases of the last 150 years.

Lord Goldsmith has a long practice in arbitration and in the interface between arbitration and litigation. He appears as counsel for leading cases in a number of jurisdictions and different arbitral institutions, including ICC, LCIA, SIAC and ad hoc in London, Paris, Singapore and India. He also sits as arbitrator in London, Paris and Singapore. He is Vice Chairman of the Hong Kong International Arbitration Centre, on the panel of arbitrators for the Dubai International Arbitration Centre, a member of the Singapore International Arbitration Centre, a member of the International Advisory Board of the Association of Caribbean Corporate Counsel, and is closely connected with the LCIA, SIAC and the ICC.

He co-chaired a Task Force on ICC arbitration involving States and State entities which recommended changes to the ICC rules of arbitration to take account of special issues faced by States in ICC arbitrations.
